## **Community Engagement and Consultation**

Led jointly by the Office of the Police and Crime Commissioner (OPCC) and Staffordshire Police, engagement and consultation with existing members and co-ordinators, and with local residents and businesses is continuing and indeed will grow over coming weeks and months.

It's a challenging task to design a new and innovative Staffordshire-wide community engagement process in which we can all feel part, and your contribution to helping shape initial thinking is key to our success.

Through the distribution of the 2015 Precept Leaflet circulated by Local Councils from mid-March, over 400,000 households and businesses are being provided the opportunity through completion of an on-line survey to comment on Watch Updates and how these influence feelings of safety within the local community. Additionally, keen to grow our watch schemes across Staffordshire particularly with the younger generation, views and opinions are also being sought on how best this growth can be achieved and sustained.

Residents and businesses not currently registered to receive Watch Updates are being signposted via the Police and Crime Commissioner website, www.staffordshire-pcc.pnn.gov.uk or through the Staffordshire Police website, www.staffordshire.police.uk to register with NHW and receive these.

Within the Force, police officer and staff engagement is now underway and an internal staffing workshop was also held on 9 March 2015. Opportunities for police-led local engagement with residents and businesses will be maximised over the coming months, providing an opportunity for you to talk with policing about your thoughts on current NHW activities, how you'd like to contribute to increasing safety in your local area and express views on growth of Watch membership across Staffordshire.

Plans are also now underway to hold a new style 2015 Conference on Saturday 30 May. At this event, I'll be able to share with you future engagement plans and you'll be able to appreciate in more detail the part you can play in the growth and development of citizen engagement, clearly focussed on my vision of making Staffordshire even safer for local residents and businesses.
